Privacy and online safety are important to Unibot. We value Your private information, therefore we try our best to ensure that Your personal information is protected and well secured. For purposes of protecting Your personal information please read and accept the Privacy Policy.

This Privacy Policy together with the Terms of Service form the entire legal Agreement (“Agreement”) between Unibot Limited (“Unibot”, “Company”, “we”, or “us”) You as a User (“You”, “Your”, “Customer”, or “User”). This Agreement regulates relationships arising from the use of the Unibot Website <https://unibot.ai> (the “Website”) and/or Comin Services (“Service”, “Services”).

This document defines the scope of privacy and degree of confidentiality protecting the information which the User inputs during the use of <https://unibot.ai> website (“Website”). At any time, the User can, at his/her discretion, allow or forbid collection and use of his/her personal information.

This Privacy Policy applies to the Website owned and operated by Unibot and its affiliates (collectively, “Unibot”). By using the Website, the User provides his/her consent that Unibot has the authority to collect, use and disclose the User's information, including but not limited to Personal information, according to the rules and provisions of this Policy.

“Unibot” proclaims and accepts its responsibility to protect the User's private information. This document contains the rules upon which such information is gathered and used, and also reasons for disclosure of such information. These rules apply to any personal information gathered at and/or by Unibot.

The supply of Your personal data has voluntary nature. It is Your sole decision whether or not You want to provide us with Your personal information. However, if You are willing to use our Service You will have to disclose personal information as stated in this Agreement. Your personal information will be used for the purpose of us delivering our Services to You.

CONSENT TO INFORMATION COLLECTION

While using Our Website and/or Our Services, certain information is being collected automatically. By entering and using the Website and the Service You give Us Your consent to process and collect the following information:

- **Browser and device information:** we register the information concerning the use of the Website, including IP address, device type including the information about device's software and hardware etc., operating system and Internet browser type, screen resolution, operating system name and version, device manufacturer and model, language, plug-ins, add-ons and the version of the Services You are using, address of another website the User came to the Website from, time of the visit, and browser type and language version;
- **Cookie and tracking technology information:** we collect information gathered by cookies and/or other tracking technology information such as time spent on the Services, pages visited, language preferences, and other anonymous traffic data;
- **Usage information:** we collect the information relating to the usage of the Website, including Your actions on the Website if such actions are present;
- **Geolocation information:** we collect the information about Your geolocation.

- **Transaction data:** we collect the information relating to transactions such as purchases, purchase amount, date of purchase, and payment method etc.

We may also get the information from other sources and combine it with the information which we are gathering through the Website.

Personal information of the User is collected only upon prior permission from the User to collect and use certain information within these rules. Giving such permission, the User supplies such information voluntarily.

Unibot declares, that "Personal information" may include, but is not limited to:

- Information supplied by the User during filing a form and/or sending an email, which is used to connect with representatives of Unibot via the Website, including but not limited to: name, last name, e-mail etc.;
- Information supplied by the User during the provision of consultations, negotiation of possible cooperation between the User and Unibot.

Unibot never collects or requires Users to provide information revealing the racial or ethnic origin of Users, their political opinions, religious or philosophical beliefs, trade-union membership, and data concerning their health or sex life.

The user has the right to refuse from the submission of personal information at any time. In this case, the user must immediately stop using our Website.

USE OF PERSONAL INFORMATION

Collection and use of the User's personal and non-personal information are performed by Unibot for the following purposes:

- Processing User's inquiries and operations on the Website;
- Providing a Customer service;
- Data analysis for the purposes of improving offered goods, products or technologies;
- Provision and display of the content specially chosen in accordance with preferences and interests of the User;
- Notifying User about new goods, services and special offers of Unibot.

Unibot collects personal information about its Users only and does not require User's to provide Unibot with personal information of any third parties.

Personal information gathered by Unibot may be processed and stored in other countries at facilities belonging to Unibot and/or legally used by Unibot. Supplying Unibot with the private information, User permits its transfer outside the country within the bounds of such use.

PERSONAL INFORMATION DISCLOSURE

Except in situations clearly stated within these rules, Unibot does not disclose, sell, lease, lend, rent or make available personal information of the User to any third parties.

The User's personal information can be disclosed and shared with partner agencies that render services on behalf of Unibot. The services may include money transfer, data storage, payment processing, etc. These third parties will receive only the information required to provide said specific services; the information will be kept and protected by the same principles and level of protection followed by Unibot, and it cannot be used for any other purposes.

Information about Users may also be passed and disclosed as a business asset in the case of acquisition, sale or absorption of the company. In the event of this unlikely case, Unibot will inform Users in accordance with the procedure outlined below.

Unibot reserves the right to disclose and pass personal information of the User if it is required by law and when we believe that disclosure is necessary to protect our rights and/or to comply with a judicial proceeding, court order, or legal process served on our Site.

ACCESS TO PERSONAL INFORMATION

If User desires to know the amount or type of the personal information we collected from User, he/she may contact to us via email hello@unibot.ai with a relevant request. In this case, we will respond User within 30 days upon receiving such request.

In the event You desire to delete all information about Yourself from our systems and databases please contact us at hello@unibot.ai with a relevant request.

We will retain and use Your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

USE OF COOKIES AND OTHER TRACKING TECHNOLOGIES

Unibot and our partners use cookies or similar technologies to analyze trends, administer the website, track user's movements around the website, and gather demographic information about our user base as a whole. Users can control the use of cookies at the individual browser level.

The User can allow or forbid the use and acceptance of cookies on his/her computer through the browser settings.

INFORMATION SECURITY

Unibot actively monitors and enforces the information protection standards for all Unibot activity, namely:

- Limitation of the rendered access to information only to those employees who need it for providing services to the User;
- Appoint a person, who is responsible for personal data protection process;
- Signature by partners and external companies invited for fulfillment of particular functions of confidentiality treaties and agreements concerning non-use of such information for any unauthorized purposes;
- Storing of the personal information obtained from the User in encrypted form, at protected computers secured from unauthorized access.

Since there is no perfect secure method of protecting information during its storage, processing, and transfer into electronic form, Unibot does not give the full warranty of its complete safety, despite all efforts made by the company.

MINORS

Website content, and services are neither intended to be used by minors and persons under age of 18, nor designed and intended to willfully and knowingly collect, use, or disclose any personal information from minors and persons under the age of 18. Unibot will immediately remove personal information collected from children and/or search to obtain a verifiable parental consent for the collection use or disclosure of personal information collected from children, once it will come to Unibot's attention that any personal information from children was submitted or collected through the Site.

The User confirms and warrants that he/she has reached the age of 18, has all the sufficient for the usage of the Website and is bound by legal obligations sufficient for any liability that can appear as a result of usage of the Website files. The User agrees to bear full responsibility for all cases of the Website usage without distinction.
